
### 1 Overview

The vacuum pump, when used on Accutom-100, creates a minimum of 900 mbar vacuum with an airflow of 34 l/min to secure the glass slide.



#### Vacuum chuck 06176912

Vacuum chuck applicable for two 27 x 46 mm/28 x 48 mm glass slides or one 2 x 2" glass slide.



## 2 Instructions for use


The vacuum chuck for two glass slides is used in this instruction.

#### Procedure


Mount the vacuum chuck in the machine and connect the vacuum tube to the vacuum connection in the cutting chamber.



 Place one or two glass slides into the vacuum chuck and grind the glasses to the desired thickness.




If the ceramic plate is not plane enough to hold the glasses, grind the ceramic surface of the chuck before placing the glass slides.




#### Procedure

 Glue a specimen on the glass slide and cut off surplus specimen material to a thickness of 0.5-2 mm.



- 4. Grind the specimen to the desired thickness
- The specimen is now ready for final preparation on a grinding/polishing equipment



## 3 Maintenance

Proper maintenance is required to achieve the maximum up-time and operating lifetime of the device.

#### Weekly

1. Clean the device thoroughly.
